

Consent Form For Photography and Images of Children

Dear Parent or Carer

During your child's time at Ashurst CE Aided Primary School we may wish to take photographs of activities that involve your child. The photographs may be used for displays, publications and on a web-site by us, by the Local Authority (LA) or by local newspapers.

Photography or filming will only take place with the permission of the head teacher, and under appropriate supervision. When filming or photography is carried out by the news media, children may be named but home addresses will never be give out. Images that might cause embarrassment or distress will not be used nor will images be associated with material on issues that are sensitive.

Before taking any photographs of your child, we need your permission. Please answer the questions below, sign and date the form and return it to Ashurst CE Primary School. You may withdraw your consent, in writing, at any time.

- the local media may take images of activities that show the establishment and children in a positive light e.g. Reception Year pictures of new starters, drama and musical performances, sports and prize giving;
- photographers acting on behalf of the school or the LA may take images for use in displays, in publications or on a website;
- embarrassing or distressing images will not be used;
- the images will not be associated with distressing or sensitive issues; and
- the establishment will regularly review and delete unwanted material.
